



## Solid Waste Senior Discount Application Form

*UPDATED: January 25, 2018*

Under the City of Upper Arlington’s new 2018 Solid Waste Program, households in which the homeowner and head of household is aged 60 years or older qualify for a discount on their Solid Waste base service fee. To have your next utility invoice correctly reflect this discount, please complete the Senior Discount Application Form (page 2 of this document) and provide a copy of a document that includes proof of age—driver’s license or other official personal identification—to the Finance Department.

- Homeowners and heads of a household who turn 60 years of age after January 1, 2018 can qualify for this discount at any time, however, it will not be applied retroactively—the first discount will be reflected on your next semi-annual invoice.
- The Senior Discount is only applicable for the Solid Waste base fee. It will not be applied to Premium Service or to the City’s additional overheads, such as administrative costs.
- Owners of multiple-unit rental apartments do not qualify for the Senior Discount.
- **Annual Renewal:** Senior Discount customers are required to register for this discount annually.

Below is a breakdown of the pricing that will be reflected on your semi-annual utility invoice for Solid Waste (annual totals are also provided for your convenience) for Regular Service or Premium Service, with Senior Discount totals under both scenarios.
